General Rules, Risk Waiver & Hold Harmless Agreement

1. CHECK-IN, CHECK-OUT, RATES, RULES and TERMS are as printed for the current year "RATES & RESERVATIONS", as printed herewith and as posted at www.ClearLakeResort.biz; all of which apply to all children, invitees, visitors and guests.
2. SIGNED REGISTRATION REQUIRED prior to visiting Clear Lake Resort. You must be 21 years of age or older to register.
3. OWN PERSONAL SAFETY and ACTIONS: I, the undersigned, acknowledge, for myself, for all my guests, invitees, visitors, and children, that there are inherent risks of a lake vacation with water, the natural environment, wildlife, weather conditions, play areas, piers, kayaks, boats, moorings, and facilities at Clear Lake Resort, that could result in loss, property damage, physical injury or even death. Thus, for myself, my guests, invitees, visitors and children, we are responsible for our own personal safety and actions with others at Clear Lake Resort.
4. GENERAL RULES: No Subletting; only registered guests are allowed at privately-owned Clear Lake Resort. Quiet Hours are from 10:00pm to 8:00am. Be considerate and do not disturb others. No Smoking in units. Never swim alone. Do not drink alcohol and swim or operate watercraft. Children, elderly, etc. must be adequately supervised. Secure your belongings, units and vehicles. Personally double check all boat moorings with front/bow away from shore, adequate ropes and clips, secure to bottom of mooring poles and not wrapped around, not even temporarily, and not to the pier, but between poles only. Damages, breakages, malfunctions, slow drains, etc. must be reported to office/staff immediately. No pets are allowed. Guests agree they may be held liable for professional cleaning and/or damage repairs whether caused by themselves, children or guests due to facilities being left in unreasonably filthy condition, smoking in unit, intense odors, allergens (including any service animals requiring extra cleaning for dander or otherwise) that may cause delay for move-in or even cancellation of subsequent guests.
5. CHECK-OUT CONDITION: Kitchen, bath, bedroom, living room are to be ready for next guests; garbage/trash removed and in dumpster; dishes washed and put away, microwave, fridge, stove and counter-tops wiped clean; and any shared items put in correct place or unit.
6. PRIVATELY OWNED: Clear Lake Resort is privately owned and reserves the right to refuse service or occupancy to anyone for any reason (except for those prohibited by law) including but not limited to what management deems non-observance of terms or rules, behavior inappropriate or disturbing to others, racist comments, hate speech, harassment or mistreatment of our staff or other guests.
7. GUEST'S ACKNOWLEDGMENT of LIABILITY, ACCEPTANCE OF RISK, WAIVER OF LIABILITY and INDEMNIFICATION: In consideration of being allowed to visit and use the facilities at Clear Lake Resort, for myself, children and all my guests and visitors, I do hereby indemnify, release and hold harmless waive, discharge, and covenant not to sue Clear Lake Resort, its owners, family members, employees, agents, and representatives from any and all liability, claims, demands, actions, or causes of action, including attorney's fees, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or to any property belonging to me, while at Clear Lake Resort.
